

Guidance notes

- Please provide the new member's full name, i.e. no abbreviation or initials (This helps us reduce the number of duplicate members on our system).
- We collect gender information for statistical purposes only. If members would prefer not to say, please leave blank.
- Please enter the member's mobile phone number. If they don't have one, please provide a landline number. Where possible, enter the new member's email address.
- Members are required to affiliate to the National Organisation only once. Where a new member is already a member of another ARA (and has already affiliated and paid their membership fee to Active Retirement Ireland through the other ARA) ask them to fill out the above section and do not include an affiliation fee for them.

***Under GDPR Guidelines, we will only use this information for the purposes of communicating with you on membership matters. We will not share your information with any third party unless, in the case of your ARA secretary where it is for potential new members to join your ARA.**
